As a show manager/representative, I understand that any show designated as a UMH National Sanctioned Show must include at least 15 required UMH classes and a show designated as a UMH Regional Sanctioned Show must include at least 4 required UMH Classes. Classes are to be chosen from the list of UMH High Point Classes that are listed in the current UMH Show/Rule Book or on line at www.unitedmountainhorse.org. A show may include as many UMH classes as desired by management and may include other local optional classes or other breed classes, in addition to the listed UMH National or Regional Sanctioned Show classes. **All classes and show schedule must be approved through the UMH office.**

If the above named show is requesting sanctioning as a Regional show, the undersigned agrees to contact the UMH Regional Representative(s) of the Region(s) for show date coordination and for the list of High Point classes designated for the Region(s). **Please note that KY is not a region. A regional show cannot be held in KY).** A list of UMH Regional Representatives can be found on the UMH website (above), in the UMH magazine, or in the current UMH Show/Rule Book.

I understand that I must use a judge from the UMH Approved Judges list for all UMH Sanctioned Classes, and this **judge must be approved for availability with the UMH office prior to hire.** I may request a one-time guest judge card, with approval through the UMH Office, for a judge not currently licensed by UMH, subject to applicable guest judge fees and requirements. The UMH approved Judges List will continue to be updated on the UMH web site with availability according to UMH rules for judges. I understand that if the show is approved as an AAA show the UMH licensed judge must hold an AAA or AA judge's rating. Shows rated AA or A may contract an A, AA, or AAA rated licensed UMH judge. I understand that a UMH steward and/or UMH representative may attend this event and that said person(s) has authority on the competition grounds as described in the UMH Show/Rule Book. I will be provided the name and phone number of a UMH contact to answer any questions, if no steward or representative will be present.

I understand that a DQP is required for all UMH National Sanctioned Shows and that a DQP is not required for UMH Regional Sanctioned Shows, but is highly recommended. UMH may elect to not sanction a show that does not employ a licensed HIO. UMH has an approved HIO program (UHP) and, when requested, will send a UHP DQP, if one is available, and the show will receive a discount per horse inspected. If a UHP DQP is not used, this application must disclose the HIO to be used. If no DQP is used, show management accepts the responsibility for monitoring the welfare of the horses participating in the show.

I understand that UMH will include this show in the national advertising campaign. I agree that UMH shall have complete ownership and use of any videos or photos it arranges to have taken of the show or class participants and that UMH has permission to take photos and or videos.

I agree to provide to UMH all reports, copies of class sheets, show results, and other materials in a complete and timely manner. I understand that failure to follow UMH rules for sanctioned shows and failure to provide reports and forms needed by UMH after the show, may affect sanctioning in the future. I agree to review and abide by all requirements of show management under published UMH Rules and Policies.
